My Dear President Obama,

Part of the job of a good leader is to be honest and upright with all of the people of his nation. As a Christian, one who fully believes in and currently worships the true god of this universe and creation, named Jehovah, god of Shem, god of Abraham, Isaac, and Jacob, one would endeavor to follow Christian principles even as President of any nation. Such is my calling.

I, additionally, hope to be installed as President of China by China's current communist government and bring sweeping changes, upright changes, positive changes, to the whole nation of China by voluntary measures and not by the subversion of China nor by violence or the murder of China's communist leaders.

If a man wanted to do good in life, he has to prove himself to be worthy. I hope to gain the love, trust, and respect of the people and of the government of China. My doing the same in America, since this is where I currently live.

I am writing to ask you to rethink all that you have done and to open your heart to God. Perhaps, for your own sake, for the sake of your nation, and for the sake of others (myself included). This is the right time to honorably and sincerely do this.

God rules, truth rules, and integrity towards mankind rules, rather than hidden lies and evil deeds done in secret. Your nation is bankrupt, the Iraq War and other wars which your nation is fighting is illegal as you do know. Why continue on with the old policies and strategies, when you can learn to adapt your nation successfully to a new day and with truly good and upright people (allies), who think as you do (formerly did). Why desert a winning hand, when strong winds push you the other way? No faith in God, perhaps?

Do not sell Taiwan, a rogue and illegal nation, 6 billion dollars of arms. I agree that she should be protected as she is a shining example of democracy. Do not undermine China's regional strength and economic power by encouraging or brokering unequal treaties or regional economic pacts and alliances without China's full participation and approval. Especially, to not promote the spread of true teachings of Christ by way of Christ's command at Matthew

28:19,20. To go against and not allow his commands and truths to be taught and to be and put hindrances in the way of God's work upon this earth? Are you not a Christian?

I am, also, sending this very important letter to a few churches in Hawaii, because I am seeking their support and I would like to keep them in the loop as to what is occurring.

We, the Chou clan, were behind the scenes on many things and movements in the old days in Hawaii. The founding of the Fort Street Church and the opening of the Wo Fat Restaurant, named after our ancestor of the 1700s BC, are among such examples.

China needs economics in which to grow and prosper. China can be America's largest and most helpful nation in America's time of plight and deep recession. If you go against good people, who do not mind and would love to help you, then you are only weakening yourself and your nation. Would you trust in criminal acts of subversion, rather than to trust in an invisible god?

Do not do things to further undermine China. Speak with me and allow me to speak with and meet members of US Congress, Committees, the Pentagon, and other leaders in Washington DC and allow us, all of us, to build a better and cooperative world, rather than to play evil and competitive games, criminal and murderous games, which no Christian or man of God in his right mind would play. The world will always be like it is, it is the large mistakes that this nation should avoid.
