Subject: POLICE AND LAW ENFORCEMENT MISCONDUCT AND CRIMINAL WRONGDOING.

Officially by China's history and by the installation of CHOU Shun Cheong, by China's Imperial Court (the senior leadership of the Chun clan-Ming Dynasty, Chow clan-Chou Dynasty and many others who traditionally held and maintained the official mandate of China) and official Imperial lineage, I am China's official and current succession emperor today.

Many of you know me or have met me as my family has lived in Hawaii since 1871 and we (China's Imperial family) are quietly known to many people in select and government circles. My family is called the Chou Dynasty or Chow clan (Zhou in Mandarin, Chow in Cantonese, and Jo in the English romanization of my family's Hebrew surname).

I am writing this letter of complaint basically about police and prosecutor's misconduct and criminal wrongdoing. These are issues that have been addressed by many other citizens in the past in Hawaii, general issues as well as specific issues, that have never been corrected by the police department and prosecutor's office. And, additionally, never corrected by any other law related entities. Some of these issues are being currently addressed by me in this letter. I am a U.S. citizen and resident of the State of Hawaii. I am China's official Han-Chinese emperor and thereby head of state in exile. I am, also, a U.S. citizen and esteemed and dignified member of this community.

I am a very important person internationally and I have been involved, directly and personally, in many international conflicts and crisis in my capacity, personally, as China's emperor and head of state and concerned world citizen and, professionally,

as a political negotiator. There is no reason to not believe and put faith in my honest and honorable testimony and words. I always try to be upfront, truthful, and accurate with my words. I despise people and organizations who hold less than honorable dealings with the general public and in the carriage of their responsibilities. We live in an upright world, which is not supposed to be lawless and there is a public perception and expectation that law enforcement bodies will respond honorably and in an upright fashion when they are called. Sometimes, law enforcement bodies need to follow the spirit of the law and at other times, so as to not get sued, the law as written.

I have found through my own personal experiences that the police have been negligent and even criminal in the administration of their duties and have gone against innocent citizens, complainants for one reason or another. Police have acted criminally and have falsified reports and statements. I am wondering why this goes on in our Honolulu Police Department.

Then, too, I have seen law enforcement organizations punish and indict people who are alleged to have committed crimes without having sufficient proof, proper evidence, and mostly based on hearsay or the judgment of the Prosecutor. When will civilized society ever learn? And why don't you people in law enforcement follow the laws as written? Good law enforcement depends on the talents of a good head administrator. A truly upright man, experienced and wise, someone who will follow the law, rather than to become the law.

We are all human, sometimes prone to failings and mistakes. Yet, the judgment of both the police and prosecutors is being called into question here.

From my own personal and recent experiences when officers come out on calls, it seems as if "they already know me" and a judgment is already made as to the disposition of the case even before hearing all of the facts. When I ask officers to listen to what I have to say and to the details of my complaint (against another party) the officer(s) refuse to listen and proceed with the case. This is wrong as well as having it in for someone.

And still, as of this day, these kinds of things keep happening with the police coming out in anger towards me, though I did not provoke them, and twisting the facts.

Perhaps it is not only the officers, but their supervisors who are responsible. And it seems as if the police do not want to correct their mistakes and are willing to allow such things to linger. I would certainly like to know what is truly behind all of this, what happened and who is responsible.

I have reported crimes and incidents to the police and they have intentionally tried to make me look bad and guilty of misconduct (false reporting) of some kind.

I have been subject to maliciously police beatings and falsely arrested about four or six times and once left for dead. I was arrest by police to cover up the beatings. A number officers have lied on police reports and in their testimony in court. Yet, the police commission and internal affairs have dismissed my complaints! How so? How can any legitimate police corrective body dismiss a legitimate and accurately worded complaint and allow an errant officers to go unpunished!

My complaints were honest and truthful and accurately worded. Does this mean that the Commission and Internal Affairs is unable to apprehend and arrest errant officers committing dishonest and criminal acts against citizens? If an officer says that he did not do what the complainant has alleged, does the Commission and Police Internal Affairs then vindicate the officer? And how about the possibility of allowing the officer to testify in the presence of the people he falsely arrested and have beaten? Ever look a guilty person in the eye? Do you people know how to apprehend police officers guilty of misconduct and criminal wrongdoing?

Perhaps, people running these organizations need to step down in favor of people who can do the job of policing the police?

If I had my choice of who I would chose to head our police department, I would choose an honest man, an upright man, someone with experience, who will look after the betterment and welfare of society in general and who will protect people and not be afraid of retaliation from other officers. Someone with a good command and view of our current world, a greater and larger society and international world. We live in a just and upright society, a world of laws, do we not? And we do not live in a lawless society, where men make their own rules (instead of following them) and continually violate the laws and the rights of citizens.

I would choose a man who is able to train, hire, and oversee his entire department and get rid of the "bad eggs", whether senior officers or rookies. The same is expected in all of the other law enforcement agencies.

And when we are wrong, ourselves, we admit to our mistakes and we correct them as the late President John F. Kennedy said to our press and thereby to the nation. <http://watchmansclapper.wordpress.com>

When citizens complain some of us do not lie and are very accurate in the wording of our complaints and observations. Yet, our complaints are not always upheld. Why!? It seems as if both criminals and police have gotten away with blatant violations of the law and violations of our inalienable rights (inviolable, absolute, unassailable, inherent, unforfeitable rights granted by natural laws and by religious codes; laws and rights from God). We live in a Christian nation. A nation of people who are and profess to be Christians and our nation's government is a secular government, which is supposed to respect the rights of man.

My family fled China and came here to live, due to senior members of our family circle coming here. We left China for a better way of life for future generations and due to the threat of our family being assassination by opposing political forces. We fled China to come to Hawaii, a distant land, a Hawaiian kingdom, dominated by Whites and by a White and Christian society. America, a land upright in its nature, legal, and law-abiding.

We fled China due to assassinations and came here for safekeeping for our very lives. China in the 1600s was governed by the Chun clan and family (Han-Chinese). In 1644, Manchurians, foreigners, people from the north, invaded China and conquered China. And China's Imperial family, then consisting of the Imperial Chun clan and Chou Dynasty clans, went underground and into hiding. Since Manchurians were not Chinese, our Han-Chinese lineage, succession, and mandate to rule China was continued with the installment of CHOU Shun Cheong in 1644. See the above genealogy records for China's official Han-Chinese succession which was continued by the ruling family, my family, from 1644 to present. Manchurians are not Chinese, so therefore our Han-Chinese succession was continued, rather than to accept Manchurian rule of China.

We are monarchist and in today's world, we are part of China's present government. In these modern times, the king or royal head of any nation is the official head of state and president of that nation. So upon my return to China, it is expected that the government of China will install me as President with Hu Jintao as China's Vice-President. Perhaps, this may be no more than a pipe dream, more than a reality, but never the less by the history of China and by China's Imperial Court's official installation of CHOU Shun Cheong in 1644, I am China's official succession emperor today.

I hope to gain the love and respect of China's present government as well as the love and respect of all of China's people. I hope to gain the love and respect of all of America's people for my eventual return to China.

My family has always tried to put our best foot forward in this nation and maintained honorable conduct in your eyes and by your standards and principles. Never would we violate a law or principle, so as to gain your trust and your approval.

It is my goal and mission based on my family's heritage is to return to China and insure that China will always have good government, righteous and upright. My goal and mission is, also, to return god to China.

In ancient times, my family worshiped the true god. The god of Shem, the god of Abraham, Isaac, and Jacob. No other ethnic grouping of man did this or carried God's name and his faith with them. Somehow China, becoming Hamitic, lost her relationship with God early in its history and so I would like to honorably bring God back to China. This is part of my mission. It is a Christian mission, which I support, sponsor, and promote out of the love of my heart for God and due to the blessings and teachings that I have received. I am a good man, a truly good man, returning to China for the benefit of the Chinese people, for their blessing from the god and for a far better world for everyone to live in.

I have written to the last three Presidents on the above subjects and to our current U.S. President, someone who was born in Kenya, a good man and very well-intentioned. And I informed all of them of all or most of the above issues. I hope to have your nation's love and I hope to be successful in my return to China bringing God's word and a righteous and upright government to China to a pagan land of 1.3 billion atheist.

I hope that you will allow for a meeting with me and that you will admit and correct all of your errors, after a full meeting with me. If I am at fault, I will amend my ways and will reflect a better picture for all concerned.

I act in the name of God and by my family's authority as people of the true god, as Hebrews, God's family, hereon earth, called the Jo (Jehovah) Dynasty. We, the Jews, and Saddam's people from Takrit make up the main lineages and branches of the Hebrew nation.

In the Summer of 1990, then-President Bush said to others that he was willing to give "serious consideration" to my recognition as being head of state of China and by granting us recognition, we (I) would be qualified for U.S. Secret Service protection and protection from illegal and malicious beatings (as well as from false and malicious arrest) from local police among other things.

In the Fall of 1990, I successfully negotiated and secured Saddam's agreement to the Bush White House demands for his withdrawal from Kuwait. And this illegal war against Iraq and corresponding war in Afghanistan should have never happened, if the Bush administration, not necessarily President Bush, had listened. My recognition was tabled at this time as my position differed from Washington DC's plans for a war against the nation of Iraq.

I wrote to the last three Presidents (President Obama included) asking for official recognition so as to qualify for U.S. Secret Service protection and for rights under the Vienna Convention on Diplomatic Relations, which I am qualified for under U.S. and international law. I am a foreign head of state of a communist nation, a man who is an American in essence, spirit, and at heart. A man that is a natural born citizen of this nation. A person who was victimized many times by your nation and abused by the law.

With the coming of my presidency in China, the nation of China will have good administration of its laws and fair treatment of everyone concerned and China will become a good Christian nation, a fully democratic state. What better gift could I give this nation and world then that. In the meanwhile, I ask that the proper corrective corrections, above, as well as a meeting with me to take place.

I am not necessarily against a communism. I believe, as an American and true Christian, that all people can and should be good and can and should worship and adhere to the word and laws of God. With a good leadership any nation can be better. I seek not to strengthen a communist nation, but to allow China to grow. And by allowing China's its faith, as China once had in pre-history ancient times, with Hebrew people at its helm, China can grow and prosperity in relationship with the rest of the world and receive God's true love.

I am of ancient Hebrew paternal ancestry and so, very skillfully, this is my calling. (1) To revive the Chou Dynasty (Jehovah Dynasty), without displacing China's present regime, and to insure that China will always have good and upright government and (2) to see to the preaching work in the last days of this wicked system of things.

Without dialogue and communication the right things in any nation and among people can never take place, as people are not mind readers and agreements can not be had with a common understanding. Dialogue is, thereby, always necessary to build trust among men and to allow them, those who understand, a true vision of what is to take place upon the surface of this earth by God's laws and Bible prophesy.

By allowing an atheist nation her day, 80 percent of China is atheist, whereas 80 percent of America is Christian, under God's rule, we act in fulfillment of God's word and we make this world a better world for all people in which to live. This is something that U.S. President Barack Hussein Obama II and all other people of this nation's leadership wanted at one time or another, I believe, and still do desire. To have a nation peacefully become an good ally and friend, rather than to see nuclear war breakout among nations. Sometimes, life is like a chess game and we, the experts (the decision makers in Washington D.C.), think that we know it all and can see all of the possibilities. That we have exhausted all known human reasoning and that there are no other solutions than what we have seen and could humanly devise. Then along comes a better chess player, God himself, who humbles us. As a high school chess player and ranking member of my high school's chess and debate team, I have learned and seen this to be true.

When we have seen all of the possible moves and have exhausted our hand. Lo and behold, there is another way unto a greater power.

I seek good relations for China with the West, friendships never expected. As China grows and becomes a democracy, a true democratic nation, she will want and will seek America's friendship. China will have economic needs and needs to grow, economically, and not be restricted by illegal or poor political and economic tactical maneuvers by the United States of America. The sale of military arms to a rogue nation (Taiwan) is illegal. And to pass a law, the Taiwan protection act, does not make our arming of Taiwan legal. I am not in favor of arming Iran or any other nation, when that nation is not ready for democratic rule. And I do not play games of one oneupmanship and bargaining. Just as God is absolute, I try to be absolute, righteous, and upright. My decisions are based on righteousness and I will yield to America when America is right.

Should we try to weaken China? Debase her and take her economy down through a series of trade pacts and agreements with Asian nations? Or remove the once favored trade status on China's exports?

When a nation is coming to God, that is not the time to weaken her.

I am not against every precaution of yours (your nation) against non-democratic nations. I am saying that we must play fair and play by the book, God's book, in allowing other nations to see God's true love in us and through us in order that they too might learn of God's love and humble themselves to the true leanings of the true god. We must be a shining example of goodness for other nations to follow. And the Bible says that when a good king rules, the people rejoice. So, this is how it should and will be with China in the last days of this system of things.

Do not arm Taiwan with 6.4 billion dollars of illegal weapons of mass destruction. Do not impose steel quotas and fees. Do not foster Asian trade conventions as such will weaken China. You, your nation, are acting illegally, unconscionably, by upright and god-like standards as you are not operating in your hemisphere of the world. Refer to my earlier letters to many of you (ranking members of Congress and others in Washington DC and the Pentagon).

It is better to allow China to grow and become like Canada in relationship to the United States of America. Doing so is not wrong and there are many Chinese in America (from the US, China, and Taiwan) who favor and would like to see this happen. If you do not allow God, Jehovah, his day in China, I am saying to you, you will be facing the many sins of your nation's past. The many killings and the murders of U.S. citizens, as few or many as have happened, by your government and its direct hand. The murder of John F. Kennedy, Robert F. Kennedy, Martin Luther King, and John F. Kennedy Jr being among them. And as many Americans do know 9-11 was an inside job created by our government to look as if terrorist had done this. Our nation creates and fabricates stories, situations, wars, and murders other people and other nations in order to maintain ourselves as the number one power in the world, when all of this is not really necessary.

What all of our nation's sins amounts to is poor planning, poor intelligence work, belligerent people in high places dictating what to do when they have no real solutions, no open and free communications to learn fact from fiction, and greed without the sharing of ideas. When will all of this ever change? Certainly not with Obama and the many people whom he has misled.

The real heroes of America in this time and era are people like JFK, Bill Clinton, Valerie Plame, Oliver Stone, Alex Jones, and many others. People who have stood up against adversity in the face of losing their jobs and careers and told the truth about

government misconduct.

Oliver Stone exposed the truth of the John F. Kennedy murders. Alex Jones exposed the truth of 9-11. And I exposed the truth behind the Iraq War, which hasn't as of yet been published by this nation's and the world's newsmedia.

Rather than to let little Black Sambo fool you and he himself allowed to run around in circles as our childhood stories have taught us early in life.
