SUBJECT: Foreign Head Of State Requests Official And Quiet Recognition (As My Security Needs Come Into Play Here), Official U.S. Secret Service Protection As Provided For By U.S. Laws, And For The Terms Of The Vienna Convention To Be Enforced By Your U.S. Attorney On My Behalf In Your Nation For My Temporary Stay In Your Nation.

Dear President Obama and Secretary Clinton,

I am writing to both of you once again with reference to my many letters to you, including my letter dated February 24, 2010, to ask for official U.S. recognition and rights thereby accorded. For U.S. Secret Service protection and the services of the U.S. Attorney to deal with and deflect lawsuits filed by government and by U.S. citizens and others. I am writing and asking in my capacity as a foreign head of state and as China's official succession emperor, whose family currently resides in Honolulu, Hawaii. My family came to this land, a Hawaiian kingdom, at that time, dominated by American Whites and governed by a Hawaiian monarch with a White Cabinet and White-led and advised government. My grandfather was the first in my family line to arrive in 1871. We fled foreign (Manchurian) rule of our nation and to escape certain death, if we were discovered in back in China. During the 1800s there were many Ch'ing Dynasty or Manchurian sympathizers, who supported the foreign government, including people of the Han-Chinese (very surprisingly!). And so we could not and never did come out with a public broadcast of who we were and of our family's heritage and succession. Ordinarily, by official Imperial custom and tradition, when a dynasty ends it leaves back a main prince lineage for the entire dynasty, so that there would be some accountability for the affairs of the then-previous ruling dynasty. Instead what you find is that there was no such thing left with the ending of the Ming Dynasty and the Chou Dynasty was selected by Court and CHOU Shun Cheong was then installed by the senior leadership of the Ming Dynasty's Chun clan and by others, who traditionally held the mandate of China, on October 30, 1644. China's official Han-Chinese Imperial succession and related families, then went into hiding from China's foreign, Manchurian, invaders. See above genealogy files for reference.

My family came here in 1871 in secret for our protection and we have been here ever since. We had the informal, secret, and quiet backing of your government. And every President from Abraham Lincoln, I have been told (hearsay), was told and knew of our presence in your nation.

It was not until the Fall of 1990, that my family began to come out to people, semi-publicly, with our heritage and to widely broadcast who we were. This I did quite often and frequently as I was very anxious to promote and actualize my family's Chinese and Hebrew-based heritage and succession.

The objective of my family's present dynasty is the orderly and upright rule of China, even under communism, and the maintenance of the true worship of God, even if it is my own family that maintains the worship of God (Mandate of Heaven) alone. And it is my duty and mission, therefore, to return the worship of God to China where 80 percent of China's people are atheist and do not know God.

80 percent of America (United States of America) are Christian and they enjoy salvation as given in Matthew 28:19,20 as well as the abundant blessings of the true god. Jesus commanded his followers, Christians, to go to the nations and preach; bringing the word of God's salvation to people of all nations. And so it is my obligation as a Christian (Methodist) and my obligation as China's paternal father and hopeful next President to maintain my good conduct before the nations, to return to China, and to, without agitation to China or to the communist government, bring God back with me to China. The land of my forefathers (pure-blood Hebrews), who once long ago worshiped the true god in spirit and truth. We, my family, are from the settlement of Joktan (modern day Iraq), whose people were conscripted by Nimrod and our family's settlement name was changed (to Calah) in favor of our Hamite conqueror. It is no fun to lose one's identity and lose one's standing before God as one loses one's principles in favor of someone (Nimrod) who does not believe in God.

When God dispersed mankind from Babel, Nimrod's Hamite bands were swept eastward in a migration called the River of Hiddekel (river of men or mankind going eastward from the Garden of Eden). My family was caught up in this migration and settled in China, sometime much

later than all of the other early settlers some three or four thousand years ago.

So, it is this biblical history that will surface with my return to China as well as the true worship of God. My family is well-situated in China so I do have and will have, in the very least, access to the senior leadership of China's communist party.

Whether I am successful or not is not the question, it is one's true and sincere efforts to the doing of God's will that counts. And I hope to gain the respect, love, honor, and cooperation of China's government and people and I hope to gain the same from all of the people of your nation. For a man wanting to do God's will and to Christianize the whole of China and to bring about a true and everlasting peace in China, which will include a democratic principles and a truly good and upright nation, is something for all Americans to cheer about and welcome.

Any man doing this should be thought of as being a sort of Martin Luther King, a Gandhi, or even John F. Kennedy, our beloved and well-esteemed former U.S. President.

So, this is my task in life and I am once again asking you for quiet, yet official, recognition for my status in your nation. Your doing so will legally qualify me and my immediate family for U.S. Secret Service protection as well as for rights under the Constitution of the United States of America and also qualify me for rights under the Vienna Convention on Diplomatic Relations, where I am immune from prosecution of any kind and our local police, prosecutor, and State of Hawaii court judges can not frame me, my person and good name, especially if innocent. I have been a government whistleblower in a number of events and have, also, reported police many times for misconduct, both formally and informally. I am not so popular in local government circles, thereby, and I do need the protection of your nation's laws and that from the Vienna Convention on Diplomatic Relations.

I am once again writing (100 or more letters to you from the time when you declared your candidacy for President and over 55 to you as President) asking for the same. This will be my third letter directly addressed to Secretary Clinton asking for the above, due to my needs as a foreign head of state and international conflict negotiator.

The gripe that I had with you and still have is your status of not being a U.S. citizen. I am and my past is not without flaw or fault, yet I am a natural born citizen, unlike yourself, so, I am not sure how you are going to legally bind the affairs of your nation, do good in this world, and not be blackmailed into bad, illegal, harmful, and destructive Presidential decision-making.

I am in favor of seeing that China will always be an upright nation and that she binds herself to a good and totally upright United States of America and receives God's blessings. The United States of America is a secular nation in fact, yet its people are Christian (80 percent according to the Time Almanac). So, it would not be out of line to call America a Christian nation. It is this nation, an upright nation of God that I want to bind China to as given in my earlier letters to you and to others.

It is a horrible thing for very selfish and evil people (evil as judged by God and as judged by God's upright standards) to frame a truly good man, render false testimony, in an effort to put a stop to this man's holy efforts. Yet, such is sometimes being done daily and by people in government and law enforcement in Hawaii. There needs to be massive correction in Hawaii's police force as well as in our local Prosecutor's Office. So, by having quiet recognition and the terms of the Vienna Convention in full force I am protected by laws both international and national in your nation. This I am and have been continually asking of you and of Secretary Clinton.

Lastly, your government is wrong on terrorism and is wrong on the Iraq and Afghanistan wars, as to their true nature and who is truly behind such wars. It is very possible to immediately end these wars and bring home our troops immediately. We, our presence, are illegal in these nations and our nation's foreign affairs around the world is criminal and murderous at best! How can you a good man stand for these things. MURDER AROUND THE WORLD BY YOUR U.S. TROOPS! Should you not bring your troops home (via a good and upright political negotiator) and experience the love and true peace of the true Christian god?

My task is to return God to China a land of 1.3 billion atheist. This is not an easy task and to see your nation as a true and shining example of God's love will most certainly and definitely help.

I am not a competitor to China's government. I am not a separate entity. China is run by a communist regime and I am her official succession emperor in exile asking for U.S. recognition for my temporary stay in your nation. I am a very good person and hopefully a good and capable leader. Hoping to return God to my family's people and nation and to eventually usher in a better system, a new age, to China by voluntary measures rather than violence. I am first praying for the approval and blessing of God. I am next praying for your nation's approval and love for what I am doing and for their approval and kind wishes for my safe return to China.

I pray for the love of Christians worldwide that they might pray for my efforts in the doing of God's will and I will be sending this letter to some of them once again hoping that they would not mind.

Yours in closing. I am hoping to hear from you in the very immediate as I am without funds and without an income. I am unable to survive in your capitalistic nation without having money. I am poor and in poverty in the greatest nation (democracy) in the world with no friends, no family (essentially speaking), and no Christian brothers to share my love for God. And no one to minister to me.
