To all of the above-named individuals and nations and to whom it may concern,

I am a very important individual on the world's scene. In 1990-91, I negotiated and secured Iraq's President's agreement to US demands for his withdrawal from Kuwait. Somehow, the US government reneged and publicly on television said that Saddam had refused to withdraw from Kuwait. This was a blatant lie on the part of the US government. It seems, as I have found, that when the US government doesn't like a thing, as in my case, they ignored me. Even if I crafted and secured an international agreement like Saddam's withdrawal from Kuwait. The truth of this incident has not been published in the past 12 years by the world's press or American media. War with Syria is not necessary, as is war with Iran.

I have, also, had dealings with the Honorable Ban Ki-moon, Secretary-General of the United Nations and have found this to be less than satisfactory. Too often people and institutions are puppets of the US government and they are not fair and independent in negotiations and in their role as negotiators trying to resolve conflicts.

When you put truth on the table for everyone to see, then institutions and individuals have to shape up and conform to truth and goodness. Many times open government and open negotiations bring about good results, not always, though, as some situations do require privacy and closed negotiations.

The ball really is in the court of the US government as other nations have already agreed to such talks.
