Dear HSBA, Officers, and Board of Directors,

Officially by the history of China, I am China's current emperor and head of state in exile. My family fled China during the Manchurian occupation of China in 1871 to come to America (Hawaii) for our safety. We are Han-Chinese as opposed to being Manchurian (foreign or non-Han-Chinese people).

I am and have been looking for an attorney for a very long time and I have been unable to find and secure an attorney for my and my family's needs. There is no other person claiming to be emperor, nor should there be as my succession is the legitimate and it is the official Han-Chinese Imperial succession of China. This morning, I found your website and address online, so I thought that I would write to you and ask if there is any way in which your bar association could help me with my legal needs. It, in my opinion, is a great shame for a foreigner to come to this good and free land, be beaten and arrested, live as a pauper, catch a mild form of SARS, not have medical insurance, and no money to pay for all of his personal, medical, legal, and daily needs. To be arrested, falsely, and then, later, to live in a homeless shelter unprotected is an abomination in my eyes! How can any country treat such an international celebrity this way? Your President, local Governor, Mayor, Hawaii State legislature, US Congress, and Honolulu City Council have not responded to my many letters, nor has any assistance been provided to me. I am an esteemed and noteworthy figure. A prominent individual on the international political scene. In 1990-91, I was the negotiator between Saddam Hussein and President Bush. I secured President Saddam Hussein's agreement to the Bush White House demands for his withdrawal from Kuwait. I, later, wrote 1,400 letters to every newspaper, radio and television station in the nation, as well as to the major networks, ABC, NBC, CBS, CNN, and Fox, and no one published this story, possibly for political reasons?

Saddam was killed, murdered, by the US government, as he did agree to the surrender back in 1990-91, when I was the unofficial negotiator between President Bush and Saddam Hussein. Did any news media organization publish the real truth behind the Iraq War? Does anyone truly care? Can anyone guess why President Obama refuses to answer any of my letters and was he born in Hawaii or Kenya, as such determines if he can legally run and become President of the United States of America?

Anyway, here I am a pauper in your nation without any food, shelter, and means for my support. I am disabled, I have asthma, a back injury (possibly nerve damages to my spine), and I am unable to work. I have two damaged knees, torn ligaments, bone

spurs, and bone fractures, as well as torn meniscus in both knees. I use crutches and knee braces to walk daily. At night, I sleep on the floor of a homeless shelter, which feeds me three very small meals daily. Yet, this is not enough for a growing man of 63 and not enough for my survival as China's emperor and head of state in exile. No money for extras or for drugs and medication.

Is there any way in which you can help?

A very honorable and sincere Chinese emperor and head of state in exile, I remain. A decent reply to this letter is hoped for and requested from all people mentioned above and below.

Younger cousin of the late Premier Zhou Enlai; younger cousin by marriage-ties to the late Chiang Kai-shek and the late Sun Yat-sen; 8th generation descendant of Chang Cheng-kung (Koxinga); 5th generation descendant of Lum Tse Hsu, Governor-General of Hunan and Hubei provinces, Imperial Commissioner in charge of banning opium; grandnephew of the late Henry P'u Yee Aisin-Gioro, last Emperor of China (Ch'ing Dynasty); great-grandson of Chow P'an Lung; China's current Emperor, head of state of China by virtue of title; and China's symbolic Son of Heaven.
