Dear President Obama and Secretary Clinton,

I am not an enemy or competitor to China's government and neither am I an enemy or competitor to the government of the United States of America. I am a cultural and political symbol. I am the nation of China's current succession emperor-in-exile. My grandfather of the 1640s was officially installed as the Emperor by court, by the major princes of the Ming Dynasty and by others who traditionally held/maintained the mandate of Heaven, during the Manchurian conquest of China. Manchurians are not Han-Chinese, but are people of a foreign or different race. If the Japanese people conquered China, the emperor of Japan would not, today, be recognized as the emperor of China. If you examined the history of China, you will find that what I am saying is true and that every nation around the world, generally speaking, has its own king, monarch, or royal lineage and such is the case for China. Refer to my website for my family's genealogy

records and to view the official Chinese installation of my family's monarchy line on October 30, 1644. This is the exact same day in which the Manchurian emperor was installed.

The king or emperor of any nation is considered to be a part of that nation and not a separate competitor to its government. As you do know, both of you, my family fled China in 1871 to escape Manchurian persecution and certain death. We then are entitled to recognition and U.S. Secret Service protection on an official basis by U.S. laws. We are a part of the nation of China's government and we are its official monarchy fleeing for our very lives from a foreign (non-Han-Chinese) Manchurian dynasty and government.

In 1990-91, I negotiated and secured Saddam's withdrawal from Kuwait. Saddam had agreed to terms that would be considered reasonable by all governments around the world and it was the U.S. government that refused to acknowledge Saddam's agreement, via Saddam's urging and communication with me, and my sending word to the White House. Your nation made war with Iraq illegally and refused to comply with the rule of law. Your nation illegal captured him and illegally turned him over to his enemies knowing that he would be killed. Thousands of years ago, King David put Uriah on the front lines knowing that he, too, would be killed, so that he, King David, could marry Bathsheba, Uriah's wife. Essentially, your government's actions parallels that of King David's. The Jewish King David, thereby, committed a very great sin not only unto himself, but against God!

Then, too, is it ever right to interfere in the internal affairs of another nation, (1) to incite riots and then to overthrow that nation's legitimate governing regime and (2) to kill/murder that nation's leader? Is your government guilt-free and will any international government body prosecute your nation for its wrongdoing?

If your nation's people were rioting and you sent in the National Guard with tanks, is it right for any other nation, as a matter of fact, to shoot at and destroy your tanks?

I, sometimes, wonder why our nation's press was absent in all of this? I, sometimes, wonder why the world's press was, also, too, absent in all of this? Justice should come forth, if honor in this world is to survive!

If your nation commits a very grave sin, kills or causes to be killed a foreign head of state and smears his name prior and in the process, would your nation, the United States of America, or would you, as president, intervene in such a situation and reverse the course of your nation and set aright your nation's path and errors. Would you/your nation compensate the nation or nations or individual or individuals that you/your nation have wronged? And, to add, make public the truth of this situation, highlighting your errors to the world. Would you ever make a public apology? Would you be too afraid to do so? I would make a public apology, if I were President and in the wrong. These questions deserve an immediate answer from you and should be publicized national and international along with your answers.

Also, too, you should allow for international criticisms to be heard and truth not covered up.

If you or your nation don't like some foreign head of state, would you have him killed like King David did to Uriah by dishonest deception? How honest are you any way and do you have enough integrity to always do the right things? What does your past performance and your nation's past performance say about you, your nation, and these issues? Care to accept my challenge on these issues and appear with me on national television? On open and international programming stations?

I strongly suggest that you immediately make known the real truth of the Iraq War as well as the same for the many international conflicts that the United States of America has been involved in, so that truth and the true god might shine through and might your nation reform from its ways. Isn't the slogan of your nation "In God we trust"?

Lastly, to get back to the original issues that I wrote many letters to you (over 200) about was the matter of my security, U.S. Secret Service protection, and having my needs met while I am a guest in your nation. I am poor, unemployed, disabled, and homeless. I have no money and no income at all. I am a good man, a man of great integrity, who hopes to lead his country, whether democratic or communist.

I want to work with your government to see that a true end to the Iraq War is had and that the people of Iraq are truly and fully compensated for the illegal and murderous war that we brought to their shores. You should not be afraid of the truth being made known and published throughout the entire world. And that U.S. aggression and greed ceases and never arises ever again!

If I am wrong, may I apologize and amend my words. If I am right, would you care to work with me to change the course of history from U.S. world dominance to a better world for all of mankind based on God. This I would most happily rejoice in and this will make God's heart rejoice at seeing man's heart being reformed and man's path running along godly lines

I am poor, without any money, unemployed, homeless, and disabled. I am in need of medical care, for things that your government medicare program does not and will not provide.

People say talk is cheap, so why are you afraid of meeting and speaking to a man who is a real Chinese emperor, Emperor of the nation of China? I have no money and no standing army. I am not a violent man as testified to by the wording of my website. I am a believer in God and my wishes for my people and nation is that they might avail themselves of God's blessing, prosper, and have a better and more abundant life. Am I so evil and greedy, as an upright pauper and Christian, that you fear me and refuse to reply to my letters and refuse me an audience with you?

I have many issues always being laid against me. I have enemies or people who don't like me, yet I must always try my best to be the best person that I can be and to shine light and love upon all and everything who/that I come into contact with. Can this, also, be said of you?

I sincerely await your immediate reply and I could use adequate financial help from your government too! I have medical, food, housing, financial, security protection, and daily living needs, which are not being adequately met. I am a foreign head of state. I was the political negotiator who successfully negotiated and secured Saddam's agreement to the Bush White House demands for his withdrawal from Kuwait. I am China's current succession emperor in exile and a godly man of peace. My path is to see to the salvation and well-being of China and to usher in a new age of religious beliefs in China, a land where 80 percent of its people are atheist.

An immediate reply and/or preliminary acknowledgment of receipt of this letter is hereby sought and desired. Please view my family's genealogy files at the websites given in this letter's greeting/heading above. I would be most happy to meet with you and to make you aware of all that I speak of in my letters. While I am not considered to be a foreign policy specialist, this is one area of expertise where I tend to excel. I whole heartedly welcome a meeting with you. Knowledge is power and a good leader, leader of the free world, must know and have many perspectives before he can properly lead his nation. Meeting many foreign heads of state will most certainly help and not hinder!
