Emperor of China and Son of Heaven (living in temporary exile in the United States of America), a humanitarian and peacemaker (world statesman), Chief Negotiator and Managing Partner of Lester D.K. Chow and Associates.

A loyal US citizen holding a love for the true god and by birth and genetics a true paternal Hebrew, a descendant of Eber.

Younger cousin of the late Premier Zhou Enlai; younger cousin by marriage-ties to the late Chiang Kai-shek and the late Sun Yat-sen; 8th generation descendant of Chang Cheng-kung (Koxinga); 5th generation descendant of Lum Tse Hsu, Governor-General of Hunan and Hubei provinces, Imperial Commissioner in charge of banning opium; grandnephew of the late Henry P'u Yee Aisin-Gioro, last Emperor of China (Ch'ing Dynasty); great-grandson of Chow P'an Lung; China's current Emperor, head of state of China by virtue of title; and China's symbolic Son of Heaven.
