### **TO ALL 15 UN SECURITY COUNCIL MEMBER NATIONS AND UN SECRETARY-GENERAL:**

By now, all of you do or should know me (know of me), due to my work internationally in trying to bring about a just and fair resolution to the Iraq War (1991 and 2003). There are times when a great nation, a powerful nation, wields so much power that every other nation around the world accepts their leadership and accepts whatever directives or agenda that this nation dictates. Nations accept, as law, the dictates or mandate placed upon them by this greater nation. Whether true or false, honorable or dishonorable, lawful or not, these things are accepted. Money and political power is the world's life blood and no one opposes the greater nation for fear of reprisals and for fear of economic loss (the life and blood of all nations).

If nations are honorable and act honorably, the world would be a better place and a safer place for all on account of it. If nations act dishonorably, lies about their conduct and justifies criminal acts of mass murder, towards other innocent and less powerful nations, then the world is not a better place or safer due to the shameful and dishonorable conduct of the greater nation.

We live in a world of laws. We do not live in a lawless world. The system put in place works and nations need to abide by the principles of law, rather than to act criminally; lie to one another, to other nations, lie to the world and to the press. In 1990-91, I was the informal go-between between Iraq and the United States of America. The nation of Iraq, at that time, did not commit an act of naked aggression. It invaded Kuwait, due to Kuwait's conspiracy with the United States of America to manipulate the price oil in opposition to OPEC policies. Did Iraq, then, have every right to invade Kuwait in a policing action? Did the United States tell the world the real truth behind their illegal and criminal manipulation of oil prices? Was the act of invading Kuwait and Iraq, by the US government, illegal, as claims by Iraq that the Saba family from Jordan did not have territorial rights in ancient Iraqi territory? Can any nation interfere in the internal affairs of another nation, impose a no-fly zone and regime change? Or to even bring about the murder and death of the President of another nation, or hand him over to his enemies for execution? All of these things are illegal and illegally done by the US government!

Are you, nations, above named willing and strong enough to stand up for truth? Or will the entire world yield to a CRIMINAL BULLY? Two million deaths and innocent lives is nothing to sneeze about, especially when some international negotiator had secured Saddam's agreement to withdraw in compliance with the demands of the Bush administration. When a nation agrees and the other nation does not acknowledge the truth and chooses to unethically and illegally go to war, then that nation should be held accountable for the millions of deaths and damages that it was responsible for. The war against Iraq in 1990-91 and 2003 is illegal. U.S. (United States of America) intervention and the imposition of a no-fly zone in Libya is, also, illegal and highly criminal on the part of the U.S. and on the part of the United Nations. And when the U.S. had a real chance to negotiate and come to a peaceful settlement via myself and via Saddam's

agreement to talk, the U.S. refused and these set of facts were never published by the United States of America or by this world's news media.

I am asking, now, at this time that the United Nations not take any action against Libya and that the United Nations rescind its position against Libya in favor of seeing Libya resolve, in a human fashion, her own internal affairs. I am, also, in favor of seeing the criminal prosecution of the United States of America by the United Nations or equivalent world body for a murderous and illegal Iraq War, which took, in cold blood, two million innocent Iraqi lives.

I urge that the United Nations not make the same mistake twice. And not accept history and political relations facts, those which are in error, as produced by the United States of America in her effort to control politics and resources around the world. Too often it is the U.S. CIA (United States of America's Central Intelligence Agency) that is responsible for uprisings around the world. If not for the U.S. CIA many countries would be at peace today.

I am more than willing to stand up for the truth and to even defend unpopular entities. Truth, goodness, and the law should be equally applied to every nation. And it is truth, goodness, and the law that should prevail rather than lies. Courts and the United Nations should allow opposing nations and witnesses to give testimony, before it takes any kind of action against other member nations. Too often my nation, my adopted nation, is the criminal around the world; as good as she may be.

PLEASE cease your (United Nations) intended war against Libya and rescind UN Resolution 1973, as it is an illegal resolution and a violation of the UN Charter. Every nation has the right to enforce its own laws and standards in their respective nation and deal with its nation's intransigence and rebels on their own terms. The rebellion that you see in Libya and earlier in Iraq were U.S. CIA instigated and such would have never taken place if it was not for the U.S. CIA. Your UN Resolutions against the nation of Iraq and corresponding resolutions against Libya were based on a false set of facts and on external circumstances created and fostered by the US government. Based on this and on fraud by the United States of America at the United Nations, I cannot see how any intelligent and legal body (United Nations Security Council), such as yours, can prosecute, falsely, other nations who do not agree with U.S. doctrines and its corrupt standards. I will forever stand by truth no matter what other nations and the UN may decide.
