A lot hinges on my well-being, health, security, safety, anonymity, and Christian mission to China. I am officially, by China's history and Court installed succession, China's Emperor and head of state, thereby, in exile. My family came to this country (US) in 1871, no different from the King of Afghanistan. Three generations of my family resided abroad in Hawaii and the King's family three generations in Rome. The Afghan government told him that if he returned he would be killed, so three generations of the king's family resided in Rome. My family went into hiding and exile from our Manchurian conquerors and lived here in this country (US) for three generations. Perhaps, it may be time for me to return to China. I and my family have been loyal Americans. We support the high ideals that you have here in this nation. It is our wish to return home with the dignity and respect. We are good people, people's people. My grandfather had a small store and a farm (60 acre plantation). When people did not have money to buy goods, we allowed them to have goods free. Often times (with grandfather) giving to others without regard for our own family. As children (my father's generation), we cried silently, due to our poverty, yet we were always solid and upright American citizens. Hiding from public view, as Manchurian sympathizers would travel back and forth between China and Hawaii. If we were discovered, we would be killed and with no notice given.

No family in America has set a greater tone for democracy and American freedoms, than ours. Going to war and supporting this nation and our local communities where we lived, putting up a front so as to not show our poverty from 1871 to 2010. A giant yin was to be built in our family's honor, which could be seen from satellites orbiting the skies, but I told our State legislature, silently, no, as I felt more was needed to earn this honor.

I need the protections of the Vienna Convention on Diplomatic Relations 1961 for my temporary stay in your nation.

I need a degree of anonymity for my safety and security. I and my family still have enemies out there, possible the Manchurian Imperial family and others who in their ignorance want me killed.

The contents of my letter, dated June 15, 2010, is included, herein, and attached by reference.

I need your President to recognize my status in this nation, so I might be able to qualify for (a) Secret Service protection, done on an official basis, where these agents can be held accountable and that there will be dialogue between them and us so we might be able to communicate our needs and also communicate our needs to your government. (b) In 1990-91, I was the government to government political negotiator, who secured Saddam's agreement and cooperation as to his withdrawal from Kuwait. Saddam agreed and the then-current Bush administration, not necessarily President Bush, himself, reneged, taking our nation illegally to war. Two million innocent Iraqis were murdered by our government in an effort to illegally make war with Iraq and to illegally remove Saddam Hussein from power (illegal regime change). I would like to publicize my story to the world and suggest to Congress that the illegal killings, which are still going on by our military, should end. Our generals know what is happening and so do many people in Congress. Rather than to tell our nation the whole truth, we continue to murder Iraqis labeling them, those who resist, terrorist and dissidents. It is our nation that is criminal here and not the Iraqi people who rebel. These things stop. When is the press ever going to listen to the upright voice of reason and truth? (c) My identity needs to be protected from public view and court suits filed by the police (quietly by the State of Hawaii) needs to be corrected. I am not a criminal as public records have made me out to be via lies and false or skewed testimony.

I am poor and do not have any money to pay for dental treatments. I have muscle and bone conditions from my years of work as a carpenter and I need very expensive treatments for my joints. Both are needed in the present and immediately, recognition by the President would help as well as donations from the community and from Hawaii's local Chinese. All of the above can not wait as my needs are in the immediate.

Perhaps, this is my last appeal as even churches, a few, have said that they do not want to hear of my plight and mission. My mission, as China's official and current emperor in exile, is to gather people for a Christian mission to bring god and bibles to China. To teach the Chinese people, my family of 1.3 billion people about God and to show them true genealogy documents proving that Chinese in ancient times did worship God. My mission is to teach the people of China and Iraq about God from the Holy Bible. I told many Christian churches about my Christian mission and four to six, out of 48, have chosen to band together to have me institutionalized as a crazy person. A very despicable and UN-Christian act indeed!

I pray, President Obama and US Congress, that my prayers will be answered. I seek only good and I wish no one any evil, yet there are churches that hold to strong dogma and hate people who are Chinese and emperors even if my mission is for Christ. Matthew 28:19, 20. Perhaps, in their ignorance they act. And, also, perhaps the same can be said for our local police.

I am a highly esteemed international celebrity seeking to keep my identity out of the press and out of the public's eye for my safety and for my future work abroad as a government-to-government political negotiator. This last item should fall under national security as much of what I do is for our nation as well as for the international community. Refer to my letter dated June 15, 2010.
