(A) A Request For Official Recognition As To Qualify For US Secret Service Protection And For Rights And Privileges Under the Vienna Convention On Diplomatic Relations 1961 And All Other Applicable Laws. (B) I Am Facing Poverty (No Income And The Need For Suitable Housing) In This Nation And I Am Seeking And Requesting Help From All People And Agencies Named Above.

Message:

ONE:

I am once again and perhaps asking for the last time for US Secret Service protection and for rights and privileges guaranteed by the Vienna Convention on Diplomatic Relations 1961 and by all other applicable laws.

I am China's official Emperor and head of state thereby, in exile. My family has always ruled China or were the behind the scenes governing thread or power throughout all of China's entire history. Western customs and conventions differ greatly from what is normally practiced in ancient China, so documents like the Vienna Convention help protect our inviolable rights, due to our nation's cultural practices and understanding. Conventions like the Vienna Convention thereby becomes a necessary tool in the orderly functioning between States.

The full truth behind President Obama has never been published for the entire country and its electorate to examine. And such is necessary, so that this nation can elect a qualified and legally qualified President. Yet, people who run the Obama administration feel that they can do as they please, ignore and skirt written laws by the use of their own judicious or heady interpretation of the laws. Such is not right or correct and violators are and should be subject to punishment by law.

Can any man who is a criminal or illegal in this nation govern our nation as if he were born here? Would this man be making good decisions and does his thinking match or come from the middle or center of American thought? Should a man who has lived outside of the law and outside of mainline American activities, upright participation in the system, now determine the meaning of democracy?

What if some certain person or persons know of the President's true legal status in our nation, that the President is not an American citizen and that he was in wait of his turn to govern a defunct nation called Mombasa. Even admitting to the truth as a teenager, not being an American citizen, and holding Indonesian citizenship. Any man who has blatantly disregarded the law and people supporting and directly promoting such a fraud should be subject to the upright jurisdiction of our nation's laws.

The problem with Obama is that if someone knows of his illegal status, these people are ignored, persona non-grata, only for being upright and such people are even punished, as our government, now protecting an illegal President, uses its power unfairly and punishes such people in an effort to shut them up. Our government should never fabricate false evidence or to misrepresent the truth. Our government protects an illegal elected President by the use of its power against any and all who disagree. Doing so is treason!

As a foreign head of state, China as of 1860s and 70s, when my family fled (for our very lives), and as China's rightful emperor and possible future President under a communist regime, am I not entitled to the protection of your nation's laws, international laws, and the protections as provided in the Vienna Convention on Diplomatic Relations? Or the same, merely, based on common sense and the fact that the United States of America is a truly good and upright nation seeking to protect the weak and to help the poor. A nation who is truly upright without interpretation that seeks good relations with other nations as that is the proper way of life. That such promotes the betterment of society worldwide and promotes the common good and general welfare. Much of our nation's laws and their creation is based on principle.

If a man were illegal (an alien and not even a US citizen) and a prince of another country (Mombasa, which is now Kenya), he can not legally serve as President of the United States of America. Our nation's laws are strict and they are not flawed as Obama and his wife have claimed. Judges have illegally not upheld the Constitution, which is not a fault of the law. And errant judges should be removed from the bench!

My request is for official recognition (done quietly) and for protections as afforded by your country and in relationship to the Vienna Convention and all applicable laws. If President Obama had granted this request earlier, there would be no problems today.

My mission in life as China's official succession emperor is (1) to see to and to ensure that good government, upright government, exists in China; that the people are cared for and that peace exists in the land and between nations. (2) Since I am a Christian and a believer in the true god, it is my mission to be obedient to Christ's message as given at Matthew 28:19,20. To preach and to teach about God's kingdom, so that my nation, my people, my family will be able to love God. (3) And to see to a final end to the war in Iraq and the complete withdrawal of all US troops, as provided through upright negotiated efforts and peace.

As a general rule, I seek no other mission and I am not or try not to be a party of another nation's political activities and decision making.

This I am asking of your nation. Asking all of the people named above and awaiting an immediate acknowledgment that they have received my letter(s) and will be giving these matters their full and serious consideration.

(Letters go to church ministers, above, only to inform them of my family's legal status in this nation and to insure them that what I have told them about my being legitimately China's emperor in exile and wanting to bring a Christian mission to China is true. To save and to convert over 1.3 billion lives in China and Iraq and to bring them to God's true salvation. This is my heart's ambition and true love. Many of these Christian faiths were a part of my family's Christian worship from the 1840s in China to present. Congregational, Methodist, Lutheran, and Presbyterian Christian faiths.)

TWO:

My life is still in danger and even if it were not directly in danger, my status as an international celebrity, political negotiator, and as China's current succession emperor-in-exile necessitates some kind of adequate security protection, which only your government can provide.

In the past, a good number of years ago, I was maliciously beaten by police and homeless persons about four to six times and once left for dead. Though I have written many complaints to the FBI, Police Commission, and police Internal Affairs corrective action has not as of yet happened and police either beat me up or try to arrest me upon responding to complaints initiated by me (of physical and sexual assault as well as verbal and physical threats from other people). I am the victim here, yet the police come out and have it in their minds to arrest me. Police have in the past dismissed these serious charges as harassment even if someone punched me and sent me flying through the air with his assaults.

I do not have any money and can not therefore bring about legal action against an errant police department. I am hoping that with official recognition by the President of the United States of America, that such matters will cease. With the weight of the federal government, no police officer would be foolish enough to maliciously beat or falsely arrest a foreign dignitary. Too many eyes are upon him and the weight of US laws would be too much for any officer to risk losing his job and livelihood.

Sometimes, when police have responded to calls initiated by me, they have lied on their reports and made it look as if I were a criminal, rather than being the victim of physical or verbal assaults. Police reports and court reports are in error and needs to be corrected.

My family's nation, China, was conquered by foreigners called Manchurians. Historians have failed to see that these people are not the royal or imperial family of China and have called them such. All Chinese people are descendants of Huang Di and our hundred family surnames, plus. All Han-Chinese have a one character, one syllable surname. My life is still at risk as these people (Manchurians) have not given up their claims on rulership of China and they represent a great threat to my life and security interest.

In the past I have had some kind of federal security, but these people have also abused me, taking money from me, and damaging my personal property. To have US Secret Service protection done legally makes people accountable for all of their actions. To be illegal like Obama and to try to operate in this nation of just and upright laws will just not work as experience has shown me.

THREE:

I am poor and without a career and adequate paying job. I am unable to pay the cost of obtaining Social Security income statements to show the US Department of Education that I have no money and cannot pay my 20 year old student loans to their judgment and satisfaction.

FOUR:

While I was a student, I was abused by federal officials and employees in a Patricia Hurst CIA type of mind-game and asked to rob banks and negotiate false financial documents. If it were not for this, I, as a very sound individual, would never do such things. It is only when coerced and convinced that there was some kind of good reason or the federal government acting behind such things, do people ever act and by chance do the wrong things in violation of our conscience, our principles, and our nation's laws. President George H.W. Bush, is considered to be a family friend, President William Jefferson Clinton, and President George W. Bush have never seriously sought or pursued collection activities on these student loans, because of the above situations until Obama. I was told by other government investigators that the sum that I would or should collect against these student loan obligations would be far greater (running into the hundreds of millions) and so no US President has pushed for collection. And the Obama administration (President Obama and Secretary Duncan) has refused to cooperate with me and with my efforts to settle these obligations directly. Both have refused to answer my letters. Mind you, I am a legitimate foreign head of state.

FIVE:

I am poor and have no source of income. My family gives me \$275 per month and my rent is paid by them out of sorrow, sympathy, and kindness. They are not obligated to pay or to give me any money and there is no legal agreement existing at this time to compel them to shoulder any of my financial obligations.

I am also in need of housing or I will be on the streets soon. Government investigators have made trouble for me with my landlord and no man can take abuse and lose his source of income (rental income). Therefore, I agreed to vacate by the end of the month (July 31, 2010) and I have no place, secure or reasonable, to go. I do not qualify for federal or state welfare of any kind and I do not collect any kind of pension or financial benefits from past employment or from federal and state government financial or housing assistance.

Can anyone help me with this request?

Remember that I am a foreign head of state with very special security needs as mentioned above. Many landlords would be afraid of renting to me at any price, because of the security risks involved. I will therefore be homeless once again living out on the streets (a very dangerous condition for any foreign head of state and future President of China to be in) where it is most certainly not safe for any head of state. Could any of you, even our new Chief of Police or even local churches (UCC, UMC, Lutheran, or Presbyterian, etc), Governor, or Mayor, do anything for me along these lines? Please.
