Dear President Obama and Secretary Clinton,

I am hoping to return to China in few months (actually, the correct statement should read "I would like to return to China in a few months."). I do not want to disappoint you, but my stay in this country has been marred with tragedy. Though I am an honored and esteemed international figure, I have been treated very poorly in this country. How would like to go to China, find yourself in poverty, and eat out garbage cans. Be beaten by the local police maliciously, while China's government turns the other way!

How would you like to sleep in a homeless shelter and get up every morning with some kind of disease or illness. Strep-throat and other things which could be caught by sleeping on mats on the floor. Here, homeless people, 80 to 100, all sleep on the floor in a crowded cafeteria. The floor is mopped nightly, but the mop and mop bucket doesn't appear to be too clean. I am very susceptible to disease and illnesses, as China's Imperial son, not being used to such living conditions.

I have written to you many times, about 270 or more, and you have not responded to any of my letters asking for official recognition and U.S. Secret Service protection. As a foreign head of state, I need these things and more! I have no money, so how am I to survive and represent the nation of China with dignity?

I posted my letters online, which were, also, intended for Congress, but were never sent. It is easier for me to send out two e-mails (to you and to Secretary Clinton), rather than to 600 members of Congress.

May I repeat, I am China's official emperor living in exile in your nation. My grandfather came to this country as a ten year old boy, brought by his older, adult age, sister. Your government knows about my extended family from the time of President Abraham Lincoln's presidency to President Barack Obama. I would like to think that you would like to be known as a skilled diplomat and good foreign policy president!

Medicare (government sponsored healthcare insurance) does not cover all of my medical expenses and I am forced to go without! As China's emperor and head of state in exile and as the 1990-91 Iraq War negotiator, the person responsible for securing Saddam's agreement to the Bush Whitehouse requested for his withdrawal from Kuwait, am I not entitled to something? Something commensurate with my tasks?

I have very expensive medical needs and I am a foreign head of state, wouldn't it be reasonable to provide for my needs, rather than to have me go without?
