My dear Mr. President,

ONE:

What I need is official recognition and US Secret Service protection for me and for my family. I continually get beaten by the police maliciously and now when they come out on calls made by me they twist the facts making me, a victim, look like a criminal. Since the police internal affairs and police commission have not acted. Is there any way in which our US federal government can protect me from such abuse? I am a foreign head of state as China's legal and legitimate Emperor. My family fled China in 1871 to escape Manchurian persecution and certain death, if we were discovered. America has been good to us and we (my family) have never complained. We love democracy and the freedoms found here. We love the opportunity to grow and to be able to foster our cultural roots and imperial heritage.

There is nothing wrong with the system. It works fine and for the benefit of people. It is only people who hurt other people that should be punished to correct inequities in the system. Our laws are fine, it is people who are sometimes rotten.

The Bush administration did its best legally within what they knew and it was your grouping of people who dunned the Bush administration making them look bad to your advantage. You and your people did the same in your promotion in Kenya and everyone in Kenya loved you as many do here in America.

I have been, from memory, been beaten and falsely arrested about four to six times. Police have intentionally tried to cut me with sharp glass, while in their custody and under arrest. Not very nice people and they were not acting within the laws and within prescribed, honorable, and legal boundaries. I was punched out many times without the police asking for my version of events. And when I tried to give my version, either they don't listen or they tried to hurry me and tried to fluster me from giving my side of the story correctly. Police reports are and have been slanted maliciously in gross and intentional error. I would like my records corrected eventually as well as Court documents.

I am a very good man. Not an evil or bad man. I am usually very humble and meek. Not trying to argue with people and always trying to be polite and diplomatic.

I am dead poor with no resources at all. I live day by day eating at church soup kitchens (not a very safe thing for me to do) and by not spending money (which I do not have). My rent is paid by family members, yet they are not obligated to pay. I get \$275 a month from family members as a temporary measure, which is supposed to end.

I have medical needs and bills, as well as very expensive dental needs and I have no money to pay. I am in relatively good health, but I have asthma and bad joints. I worked as a carpenter and now at age 61, I can not do this and do labor work any more. My elbows are not able to carry heavy loads and I can not do normal labor work. My knees, both knees, give way to heavy lifting and even give way to walking up a flight of stairs (three to six rises or more). I have a permanent back injury. All of these things do not show up on x-rays and so I am not able to get government assistance payments of any kind. I did not earn enough to even get Social Security at retirement. I have a bad right ankle injured while I was a carpenter. I can not walk and do heavy work or my ankle, in addition to my body and joints, will give way to great pain. Friends help out, some, and I work one to two days a week for four hours. I allow my body to rest and recover for one to two days after four hours of work. I am permanently disabled, but no doctor will verify my injuries and I do not have any money by which to visit doctors.

I am of keen mind and schooled in the teachings of Christ, four years of college, and good parental training growing up as a child and adolescent. From my childhood, I have always kept my associations clean. I am part-Chinese or mostly of Chinese blood, some Mongolian from Mongku and some Manchurian blood from Emperor Dao Guang. My mother additionally is a second-niece to the late Henry P'u Yee Aisin-gioro. And, yet, the last dynasty or family to rule China, the Ch'ing Dynasty (Qing Dynasty), is a foreign dynasty to the Chinese people. It is my family, which is the rightful Imperial family of China. Something known to your intelligence services. Sometimes, people are afraid to testify, because by doing so they will lose their jobs. If you want to be a good and great President, you (any person) need to have experience. This is something that you lack. And by hiring Bush people and people who have been with the "system" and promoting the system (illegal and criminal acts), you will be sorry one day as these people will be running the show all over again and not you.

I am a paternal Hebrew and someone who loves God. A good man, a humble man, upright and not a law violator.

Recognition would allow me to raise money for my mission and give me the opportunity for a good paying job. I would then be in a position to better my life as well as to be able to pay-off past student loans. Because I am a foreign head of state, it is better and wiser for your government and Department of Education to take over my loan package as privately contracted bill collectors, hired guns, are not in a position to decide matters of state and foreign policy regarding debts of a Chinese emperor.

It seems as if the US government is willing to give these people half of what we owe you. Would it be better to handle all of the student loans yourself and save the taxpayers' money?

Student loan bill collectors are abusive. This they are by their very nature. If you want to set a good tone for your administration, why don't you not disallow such people from collection activities?

When I was a high school debater, the topic in vogue was foreign aid to Latin America. And should we support foreign dictators who murder their own people? Should we support such policies for our own commercial interest and ignore human rights? Our policy has been to lie to our nation about foreign affairs. Lying when we, our government, feel that we can get away with lies.

What happens when a good foreign head of state comes along. A man who is like JFK and believes in Christ and the US system or style of life in ways where our nation is and maintains an upright form of conduct. Will we and should we support such a man? This is a question for you to answer especially with respect to me. Would you rather dun me (blacken and slander my name, which will not allow me to be in good standing for my eventual return back home to China and they, the people and government of China, will thereby never allow me back into China) and go to war with China eventually? I am China's symbolic Son of Heaven and I can be blackmailed, so I do watch my conduct and try to take every precaution to insure my safety and standing before the world and community of people.

With respect to myself, dental work is needed in the immediate and I have severe cavities on almost all of my teeth. I have no idea what my dental work cost, but I suspect about four thousand dollars. I do not have that kind of money and I do not have health insurance as I was rejected.

People are afraid to make waves and do not support or go near government wrongdoing whistle-blowers for fear that the government will come down on them too. So, your help is needed and warranted. The question is are you going to follow the law and recognize me as China's emperor, which I am, thereby qualifying me to be covered under the Vienna Convention on Diplomatic Relations 1961. This is something that I am entitled to by law. This is not a perfunctory or arbitrary matter. It is granted to a legitimate diplomat. My family fled from our Manchurian invaders and court continued our line of succession and royal mandate. We are China's official Han-Chinese royal or imperial family and we came to this country to escape Manchurian persecution and certain death. Your recognition would allow a good man to be recognized by other people and by Americans who would contribute to a good government being set up in China (done without violence and bloodshed). It would now protect me from police abuse, arrest and beatings. I do not go around making trouble and the police should be disciplined. I like law and order. I like the American system of things and life in America. I wish though that you would act, because then everyone else beneath you, including local authorities, would then fall into place and abuse would not happen to me.

Recognition would allow your government, I think it's the FBI that does this, to cover my true identity as they do in the witness protection program and more (this is sorely needed!). Collection action by your Department of Education or by its contracted collectors would legally expose me to the entire world. As of now my identity is and has been somewhat covered even though mistakes were made by me. All is not lost as long as you act. This entire matter is a matter for the US President, US Department of State, and US Department of Defense (as your departments should understand the full ramifications of governance, foreign policy, and affairs of state of nations) and not a matter for any collection agency to decide.

I am in need of protections afforded by your government and in conformity to the Vienna Convention on Diplomatic Relations 1961 and other applicable rules, laws, and procedures as elements abroad and in America may already be seeking my death.

TWO:

Our war in Iraq is an illegal war and Saddam did not have weapons of mass destruction. I want to approach Congress and bring the matter before them. If this is not possible, I wish and pray that the media will blast this story worldwide in an effort to tell the whole world exactly who the guilty parties of this illegal and wrongful aggression truly are. Namely our government and country. This war has led to terrorism and to an expanded war in Afghanistan and Pakistan. This will never end and so our military and generals knowing this have in the past sought to promote and uphold the Bush agenda and sought to murder the people who resisted, rather than to be peacekeepers in Iraq. My words are true as everyone in Congress should be able to attest to. This war should end and Iraq should be set aright (the truth be told and Iraqis fully compensated), as in American law, back to the condition that she was in prior to our nation's transgressions. This I am willing to work towards and dedicate my life to resolving this matter in an godly, upright, and amicable fashion. I need your cooperation and US Congress's cooperation on the matter and I would like to first address a joint session of Congress. Terrorism can end on a permanent basis without killing people who we label as terrorist.

THREE:

It is wrong to foster war abroad and to make war through fraud. Alleging, for example, that xyz country violated this or that, when fraud truthfully occurred on our nation's part via our hasty and emotional allegations. I would like to serve as an independent investigator on the South Korea ship sinking. I am an upright man, an honest man, who would not cheat or steal from others. Not only would I be a good and upright independent investigator, but I provide solutions to clients for resolving problems that they face. I am strongly against the sale of six billion dollars of weapons to Taiwan. You can not pass a Taiwan Protection Act and expect it to hold the weight of law. Taiwan is an illegal state a rogue nation and the property of China's. I would agree that Taiwan is a shining example of a modern Asian democracy and that it should be allowed to exist. Yet two wrongs never make right and so I am against your nation's illegal sale of arms to a political state like Taiwan. There are other solutions that your government DID NOT explore. I need to address a joint session of Congress on the matter.

The sinking of the South Korean ship needs to be handled by an independent investigation by someone like myself. Someone who has a vested interest in China and is a father figure, who has on his mind and in his heart the best interest and welfare of the North Korean people. If North Korea is guilty, then North Korea will be punished as a father would do. But a war with North Korea by the US is out of the question here. If peace is restored, then all is saved. It is wrong for the US or South Korea to create and fabricate incidents and false evidence leading to war.

As everyone full well knows, John F. Kennedy and others were victims, murdered by agents within our government and these agents were never caught or prosecuted. 9-11 was an inside job, a creation of our intelligence services. I fully support Oliver Stone's findings and his version of what took place that day. I fully support Alexander Jones's and the Architects for 9-11 Truth's version of what happened in the 9-11 incident, that it was our own government that was responsible for these calamities and I would like to implement or suggest the best way out of this mess to Congress. I would propose a solution which is God-like, practical, and will bring a final and full closure to these unfortunate incidents.

My essence and main mission though is to bring God to China to save 1.3 billion souls.

Yet, I never had the money to care for my aged and elderly mother. I highly regret my poverty with great sadness in my heart.

Not only am I the father of my nation, but father of my immediate family, clan, and extended clans. So, I hope to make good, finally, if you are willing to work with me on all of these endeavors. You can not imagine all of the sadness that is in my heart knowing that I have failed and could have saved many souls close to me. This I still want to do with the pure and true blessings of God almighty.

I am a good man and a Christian, a sound and solid soul. All of the above tasks are my life's work. I do not compromise and I will not fail. Are you and is your nation with me in all of the above resolves?

I await your final reply to all of the above matters. On June 28, 2010, I will be and I am planning to send your contract collector my financial statement and a reply to their student loan inquiry. I need answers from you in writing, so that I will know where I stand with your nation, what and how to reply to your nation's student loan collector. My situation, above, is complex and can not be legally and properly addressed by your collector alone. An answer from you and/or from Hillary Clinton, both of you, and even from Secretary Gates, is hereby expected and requested. This matter, also, all of the above, including my true identity, falls under national security issues and is not a matter to be resolved in collection activities by your nation's contract bill collector.

Meeting with people and speaking to them makes any head of state a better person and a more capable individual. Gaining knowledge is power and to be closed-minded and isolated from truth is wrong. Only an incompetent world leader would ever consider not speaking to people and not being open and honest in his resolve.
