Dear President Obama,

I have written to you many times (about 170 times with 76 letters to you in your capacity as President). You are the current President of the United States, legal or not, and I am writing for your help. This is not a matter of playing games or matter which you can deny, due to my appearing to be a possible adversary to your illegal presidency, residence and immigration status, but a matter of law where I am asking the President of the United States of America for recognition based on the Vienna Convention on Diplomatic Relations 1961. For recognition in your nation as a foreign head of state. I do not play political games!

ONE:

The reason I am asking for such is (1) due to being falsely arrested by our local police, (2) due to my being China's current emperor in exile and having competitors who would like me dead (especially the Manchurian Ch'ing Dynasty family and their supporters), (3) due to my political work in the US and abroad, which puts my life at risk, and (4) due to my just being an important person, an international VIP and head of state in exile. All of this necessitates my being protected and (5) even from the press and your nation's citizenry.

I was falsely arrested about four to six times and beaten to cover up the arrest. When I call for police assistance, the police come out and try to arrest me. In a few cases, actually beating me unprovoked and unwarranted!

I am a direct threat to my Manchurian competitors and, once again, I need recognition and US Secret Service protection, where these people and this agency can be held accountable. Armies by night will not do and JFK was against this kind of presidency. You need to quietly recognize me, so I will be able to receive services from your government legally and by law. Politics, taking sides, does not come into play here and US Presidents can not and should not have the ability to decide which laws to implement and which laws not to implement based on their political enemies created by their own illegal status. The law is not something that you can judiciously choose to implement or not. As President, you are bound to implement and follow the laws of this nation. The laws were created for a good and upright, useful, purpose and to choose or not and to choose to not implement a law and thereby violate the spirit and purpose of that law means that you are lawless and should be subject to the punishments of the law.

If you are not a natural born US citizen, then you are NOT qualified to be President. By running in violation of the laws and by working with many people and by passing fairly good laws and their implementation, your illegal status disappoints many only to see a reversal and your presidency impeached for disobedience to the law. How can any wise and prudent man do this?

Then, too, (6) I need protections from elements in your nation like your nation's citizens or criminals trying to kidnap, threaten, or murder me. I have been a victim of these things already.

The Vienna Convention on Diplomatic Relations 1961 protects me from police beatings and from arrest. It protects my good name from slander by people of your nation and by unlawful actions from your government. This is a good law since a diplomat needs these kinds of

protections, due to unfair treatment by the host nation and for the orderly functioning of that diplomat in a foreign nation. It would not protect me, once I am returned to China and China recognizes my status as its official emperor. I will be covered under another set of laws at that time.

It is my current understanding that I am to write to you for these protections to be applied to me in your nation. And I am, also, to write to your Secretary of State. That you both hold a responsibility for these kinds of matters.

TWO:

In 1990, 1990-91, I was President Bush's unofficial Iraq War negotiator. I placed myself into this position as I took advantage of my heritage status to speak and/or write to foreign governments in seek of a solution to Saddam's legal or unlawful incursion into Kuwait. Your government on public television, Secretary of State Donald Rumsfeld, said "All we want is for Saddam to get out of Kuwait!" Well, I was able to successfully secure his agreement to that and much more, yet it was your government's intransigence and secret desire to illegally go to war with Saddam, leading to the deaths of two million people, 1991 to 2010, innocent Iraqis and leading to all conflicts stemming therefrom, both in Afghanistan and Pakistan. All of these conflict are illegal acts of the US government and stemming from our trying to get (remove or murder) a foreign head of state. Our nation committed fraud at the United Nations and lied blatantly about Iraq's propensity to murder its own people and propensity to go to war. We produced false evidence, knowingly, as everyone by now fully knows. Our paid CIA informants lied and set Iraq up with lies, so we could war with the nation of Iraq.

Saddam then agreed with me and agreed to the Bush White House illegal demands for his withdrawal from Kuwait. Saddam was in a funny situation, where what he did was legal – the protection of his nation within OPEC policies and the protection of his own nation's natural boundaries – yet, would have been held in a US led international court as an international war criminal, so he wasn't about to concede without some assurance that the law would be upheld in a just manner. Apparently, we, the Bush administration do not play by these rules nor do we adhere to written laws. It is sad that we, the Bush administration and the Obama administration, are a law unto ourselves and not an adherent to man's upright laws.

My birthright comes from God as I am a paternal Hebrew. Whose family was conquered by Nimrod in ancient times, conscripted and enslaved into forced labor. My family eventually migrated to China from Mesopotamia. And from China to Hawaii and California. The court installed succession means that I am China's legal and legitimate emperor today. These things are well known in your government's intelligence circles and so these should be no reason for you to say that you are ignorant of these facts.

Hawaii's police call me "a nutcase and lunatic claiming to be China's emperor", though I have never told them that in the very beginning or to the arresting officers. Consequently they beat me to teach me a lesson to not make frivolous police calls. I have called police on occasions where people used a knife or scissors on me or beaten and fucked me in public fully clothed. These are just provocations, yet the police, when they come out, have criminally and blatantly tried to illegally arrest me instead of the law violator. This is an absolute and solid fact. And the police continue to do this as well as try to fabricate non-existent facts. (Something which federal government employees, also, do)

Does it take you 170 letters before responding to an international crisis? Wouldn't honor and upright conduct on your part take precedence in all matters?

As the negotiator, I have a better handle on the issue of the Iraq War. And due to your lack of experience and due to your administration's lack of political experience, I was never consulted. Some people feel that they are high and mighty and that they would rather consult with "known" and "prestigious" people, people who were blind and responsible for these illegal wars in the first place. Isn't it about time for you to see and to help our nation regain its international standing by rectifying this situation and regaining the trust of other nations?

And as to the police, they threatened both my father and mother for fear that an old king would have considerable influence on matters. So, as you can see when people lie the facts, if uncovered and their testimony, is inconsistent and shown to be incorrect and untrue.

If you are not man enough and hold to your weakling Obama team, I would not mind going public with the truth of this illegal war to the newsmedia, both nationally and internationally. This should have been done by you long ago, when you first took office. This is an illegal war, which must and should end in the very immediate and not within a 16 month time frame.

THREE:

I am a Christian. I still hope to gain the love and respect of your nation for a mission to take the God back with me to China. With a new leader or with different people in charge of any administration, the dynamics of international politics changes. What we once thought was impossible, now becomes possible and a reality. So, I truly hope to gain the love of the American people as well as the true god's blessing for this humane mission returning to China, once again, with the coming of my family as it had in 2000-1900 BC, and the Chinese people accepted the worship of God in early and pre-history China via the Jo or Jehovah Dynasty. Everyone back then knew!

Do you think that you are a capable President, legal or illegal, where you can satisfactorily carry off the above three agendas within and with the love of Christ for your nation and do your job as President?

People do not need to be told and people in your administration are protecting your illegal Presidency. I am being dunned for a 20 year old obligation, which the previous three administrations did not bother to collect. Collection action threatens to expose my identity in court, which negates all and any security precautions that I have. This is wrong to expose China's emperor's identity and security precautions full knowing that I am poor and have no money by which to pay these student loans! Rather than to work with me, your Department of Education distances themselves and tries to follow procedural rules apart from dealing with me in proper repayment methods in an effort to protect an illegal president. This is being done to give you a bargaining chip, where I would have to agree to be silent about your birth and citizenship. Otherwise your administration would not be doing this and a honest and honorable president would adhere to the law and to prudent and upright situational circumstances found herein. Do you still want to play these kinds of games or are you going to come clean, be upright, and honest in your carriage of your sworn duty as President? It also seems as if you are using your office for your own personal agenda and polity. You should not be interfering in Arizona's state's rights and Governor Jan Brewer is in the right in trying to protect her state from illegal immigration! Why would any upright and legal president choose to oppose this legislation with so much vigor? And why would any man or president, born in America, be against Arizona's laws against illegal immigration unless he too was illegal in this nation! Does the President, especially with regard to these things, a sworn and affirmed Christian, not judge with the wisdom given to him by God? Muslims on the other

hand do not adhere to Christian teachings and many are ignorant of things truly Christian. Abraham sent Ishmael out into the wilderness so Jacob could inherit the kingdom. Will Abraham act, once again, so that his people will be able to go free? Free, perhaps, from Obama-ness. A timely reply to this letter is expected.
