Dear Mr. President,

This is my 81st letter to you as President and over 160 letters overall. Because I am not a bloody dictator and I am an upright Christian. My task is to gain a following by setting the tone of my behaviors and by being truly upright. Such as all monarchs presently do.

It is better to confront priest with their errors than to make a mockery of our churches. But when heads of the church do not correct their errors, a heads up is published by me.

I am still poor and about to become homeless. Please have everyone in Congress read my official homepage to know of my circumstance. Perhaps, someone in government will help me and also publish my plight for wealthy people in your nation to take notice of and see. It is a very dangerous thing for an international celebrity to be homeless on the streets of America, to be eating at church soup kitchens and to go unprotected in your nation.

I have no money and I can not pay rent payments. I will be out of my apartment (room) on July 31, 2010 and will have no place to live. Is this how you treat presidents of nations in your country? Where is the hospitality and will I ever receive US Secret Service protection on an official basis, where agents and contract employees can be and are held accountable for what they do?

Many innocent people are dying around the world. Killed (murdered) by US soldiers and by true intent and design by our US military knowledgeably.

Our nation is involved in a criminal war on our nation's part and this criminal action should immediately end. I was the negotiator who secured Saddam agreement to the Bush White House request for his withdrawal and yet you REFUSE to speak with me. If people in the Bush administration are guilty of war crimes, why is it that you do not indict them? How about your own sins and your not even being a US citizen.

No experience and not knowing what to do as President, you continue an illegal war and the killing of innocent people trying to defend their own nation against American aggression and against subversive elements in their nation continues. Your nation's efforts at regime change is illegal and all of the very nice looking politicians that your nation has put in place are being ostracized by these nation's people. So, your military goes into these nations and kills people in an effort to prop up an illegal political regime. How about (1) indicting a criminal Bush administration or (2) grant them forgiveness and compensate nations and people that our nation has wronged. The second path seems like the better idea and if this ever became your plan for our nation's salvation, you need to make a public announcement bringing forth the truth of a heinous and criminal war. It would be wrong to institute a US puppet government anywhere and Saddam's regime was the legal regime at the time of our nation's many and criminal wrongs.
